## October 11, 2012 COUNCIL PROCEEDINGS 6:00 P.M.

# FINANCE COMMITTEE

## **UTILITIES COMMITTEE**

In chairman Wilkie's absence, Gary Ruff reported the following:

- > Sidewalk replacement has been done in the needed areas
- > Storm drain on Sunset Drive is complete
- > Handicap ramp at the museum and driveway are near completion
- ➤ Guardrails and signage are done on Riverview Drive

Discussion was held regarding the culvert and road repair at the Richard Champeny residence on Riverview Drive.

Ruff stated that there is a problem with the existing culvert at the present time.

Oium stated that there should be something in writing, such as an agreement or contract, which states that Champeny will be responsible for the additional culvert he is requesting on his property.

## **SERVICES COMMITTEE**

Ruff informed the Council that the committee will be meeting regarding the recycling program and be inviting the representative from Waste Transport.

## PARKS AND RECREATION COMMITTEE

Chairman Larry Farl informed the Council that the committee had met October 3, 2012. The committee received the season end reports from Bob Major-Little League and Bobbi Sedlmayr-Beach manager. Bobbi Sedlmayr has requested that the Council consider wages of \$12,000 for the beach program as it had done in previous years.

Farl informed the Council that the committee accepted a winter boat storage fee from Gary Hardtke-Lockport Marine in the amount of \$1,000.00. The committee will be reviewing this for next year. Farl stated that the marina charged the beach program and the city for any assistance they gave this year, resulting in more than the \$1,000 collected from the winter boat storage fee.

Motion by Oium seconded by Ruff to approve the Parks and Recreation committee report as presented. All members voting yes.

# **AMBULANCE**

Mayor Scow informed the Council that Donald J. Ganz, requested prior to his death, to recommend the appointment of Toby Jahnke to the Ambulance Board taking his place on the board.

Motion by Oium seconded by Ruff to approve the appointment of Toby Jahnke to the Ambulance Board to cover the unexpired term of Donald J. Ganz. All members voting yes.

#### **LIBRARY LIAISON**

Farl informed the Council that the Library Board met regarding the 2013 budget.

- ➤ Requested that Foreman Debra Burce and Chief Ritscher get together and determine the locations for the digital speed sign so that the paperwork can be completed to the DOT for the needed permits
